2021 CRESSONA GROVE RENTAL AGREEMENT

1. Individuals may rent daily at a non-refundable rate of \$40 for the pavilion with the enclosed kitchen.
2. The pavilion can be reserved for a maximum of 40 guests.
3. Reservations accepted for the pavilion will not include exclusive rights to the playground, softball field or any other area.
4. Keys for the pavilion and bathrooms shall be picked up Friday during normal business hours and shall be returned Monday during normal business hours.
5. A \$10 deposit will be required when the key is picked up. After use, an inspection of the area will be completed and if no damage is reported your deposit will be refunded.
6. No person shall injure, deface, mark, remove, cut or damage any of the trees, shrubs, buildings, structures, fixtures, or any other property of the Borough.
7. Do not staple tablecloths to the picnic tables. The picnic tables must remain in place, please do not move them.
8. No person shall operate any recreational vehicle of any type, skateboard or bicycle on the grounds.
9. No bounce houses or inflatable jumping devices.
10. No removal of benches, seats, tables or other appliances without permission from the borough.
11. Premises must be vacated by 11 pm. Building and clean bathrooms must be secured by renter.
12. Garbage cans are to be emptied and trash must be placed in the dumpster.
13. Volleyball and horseshoes are provided by the Grove for your use. Please take down after use and return to the appropriate place. Horseshoes: the mud flaps must be removed from the boxes prior to use, and replaced once finished.
14. A range and refrigerator have been provided for your use. Please be sure all burners are turned off and the main breaker is off. Please remove all food from the refrigerator and to clean up any spills inside and out before leaving the premises.
15. Rules of safety and proper use of equipment must be observed. Rentals to individuals who abuse rules or equipment will be refused.
16. Renters have the sole responsibility for cleaning and/or disinfecting all surfaces and equipment before and after use of the facility to help mitigate and prevent the spread of COVID-19. Renters must purchase and/or procure all necessary cleaning and disinfecting agents on their own, as the Borough will not provide any of the same.

The renter and renter's guests are responsible for maintaining appropriate social distancing and adhering to guidelines imposed by the CDC and the PA Department of Health for the mitigation and prevention of the spread of COVID-19. Rental of this space constitutes an agreement to indemnify and hold harmless the Borough, its agents, employees, directors, and representatives from any claims relative to the spread or contraction of coronavirus or COVID-19.
